5 Day	These members have the right to play golf from Monday to Friday inclusive unless otherwise determined by the Board. Visitor's rates apply on Saturday and Sunday	\$630.00
Country	Have the same playing rights as the equivalent membership of their home club. <i>Please ask our office staff for the criteria that must be met to be eligible to be a Country Member</i>	\$465.00
Intermediate 1	Persons who are aged 18 years to 24 years and have same rights as 7 Day Members <i>Proof of age required</i>	\$400.00
Intermediate 2	Persons who are aged 25 years to 30 years and have same rights as 7 Day Members <i>Proof of age required</i>	\$555.00
Intermediate 5	Persons who are aged 18 years to 24 years and have same rights as 5 Day Members <i>Proof of age required</i>	\$320.00
Intermediate 6	Persons who are aged 25 years to 30 years and have same rights as 5 Day Members <i>Proof of age required</i>	\$440.00
Junior	Persons who are aged up to 18 years who are elected as Junior Members or transferred by the Board from Cadet Membership and have same rights as 7 Day Members <i>Copy of Birth Certificate must be attached with this Application</i>	\$50.00
Cadet	Persons aged under 14 years who are elected as Cadet members by the Board <b><i>Copy of Birth Certificate must be attached with this Application</i></b>	\$25.00

Social Club	Persons who attained the age of 18 years and who wish to be a Social member of the Club. These members have <b>no</b> playing rights.	\$10.00
